

Kali Dance Studio COVID 19 Procedures

This is intended to be a guide for all parents/guardians. Additional guidance will be followed as COVID-19 outbreak conditions change as new information about the virus, its transmission, and impacts, becomes available.

- Parents /Guardians may drop off or they may leave the student at the door once temperature check is complete.
- Parents/Guardians must arrive for student pick-up on time. All students will be required to leave the building as soon as class ends. Staff members will meet parents at the front door.
- Student's temperature will be taken upon entering the studio. No one with a fever (100 degrees) or any cold or flu symptoms will be allowed to stay.
- Students are asked to wear masks while in common areas of the building. They may remove masks in studio for classes..
- The waiting room is closed after drop-off.
- Please take your child to the restroom before they enter the studio so there will not be a line of students requesting to go. This will cut down on their class time.
- Hand disinfecting and hand washing will be part of the daily school routine. Anyone entering the building will be required to sanitize their hands upon entering and leaving the building.
- Students are required to arrive wearing their proper dancewear and will not be permitted to change in the dressing rooms.
- There will be no moving in and out of class to cut down on constant movement in the building.
- Flyers will be placed in the building to remind students of social distancing guidelines, washing hands, etc.
- Please bring your own water bottle. Water bottles MUST be marked with the student's name.
- Each dancer's center work area will be delineated at least 6 feet apart.
- An area will be designated for the instructor's position to keep distance from the students.
- CDC guidelines will be used to clean and disinfect the entire studio

COVID-19 Assumption of Risk, Release and Waiver

COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing. By signing this Assumption of Risk, Release and Waiver (this "Agreement"), I acknowledge the contagious nature of

COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending classes and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the facility or by participating in the programs of Kali Dance Studio for the Arts, LLC (KDS) may result from the actions, omissions, or negligence of myself and others, including, but not limited to, employees, volunteers, spectators and participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Kali Dance Studio or participation in Kali Dance Studio programming. On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless Kali Dance Studio its members, officers, employees, agents, and representatives (collectively, Kali Dance Studio Indemnitees") of and from all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to COVID-19. I understand and agree that this Agreement includes any claims based on the actions, omissions, or negligence of Kali Dance Studio, its members, employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation or attendance in any program or class at Kali Dance Studio.
